

**UNIFIED CARRIER LICENCE
TELECOMMUNICATIONS ORDINANCE (Chapter 106)**

WTT HK Limited (“WTT”)

12. One2One Corporate Internationalcard Service

(This Service will not be offered to new customers from 2013 onwards)

This service enables business Customers and Registered Users to make outgoing international calls through call re-origination, from any tone telephone in Hong Kong to any countries referred to in the charges. The rates of charges for this service are as charges for One2One international card Service unless otherwise advised. Charges per call will be calculated from the commencement of each call connection to the termination of that call. Calls are rated based on the commencement of the call. Charges are calculated using multiples of 6 seconds. The minimum duration or minimum charge per call is 6 seconds.

Discounts based on total monthly usage charges shall apply as set out below:

* Area A refers to the following Asia-Pacific countries: Australia, Bahrain, Bangladesh, Brunei Darussalam, Cambodia, China, Christmas Islands, Cook Islands, Fiji, Guam, India, Indonesia, Iran, Iraq, Israel, Japan, Jordan, Kiribati, Korea DPR (North), Korea Republic (South), Kuwait, Macau, Malaysia, Maldives Islands, Mariana Islands, Micronesia, Myanmar, New Caledonia, Nauru, Nepal, Oman, New Zealand, Pakistan, Papua New Guinea, Philippines, Qatar, Saudi Arabia, Seychelles, Singapore, Solomon Islands, Sri Lanka, Syrian Arab Republic, Taiwan, Thailand, Tonga, Turkey, United Arab Emirates, Vanuatu, Vietnam, Yemen Arab Republic, Yemen PDR.

* Area B refers to the destinations referred to in the Charges and which are not included in Area A.

The following Special Conditions shall apply:

- (a) For the purpose of this Service unless the context requires otherwise:
“Card” means the One2One internationalcard issued by WTT;
“Service” means the One2One Corporate internationalcard Service;
“Registered Users” means the individuals registered with WTT as authorised by the Customer to use the Service;
“Conditions” means the Special Conditions set out in this section.
- (b) When WTT accepts an application for the Service it will issue the required number of Cards and Personal Identification Number (PIN) to the Customer for the Registered Users. The Card number and PIN must not be disclosed except as authorised by WTT. WTT may change any account number, PIN or any other code, number or name allocated by WTT from time to time to the Customer for use in connection with the Card. The Card will be valid for use from the commencement date until the expiry date notified by WTT to the Customer.
- (c) WTT remains the owner of the Card at all times. The Customer will immediately return all Cards issued to it immediately upon WTT’s request for the return of such cards. WTT may demand the return of any or all the Cards issued if the Service is suspended or terminated.
- (d) The Customer will notify WTT of the loss, theft or misuse of any one or all of the Cards. The Customer will be liable for all charges arising from the Card(s) until the Customer has notified WTT of the loss, theft or misuse.
- (e) The Customer will be liable for all charges on all Cards issued to the Customer notwithstanding whether the individual Registered User is authorised to incur the relevant charges or not. WTT will render a consolidated invoice in respect of Charges incurred by all Registered Users according to its normal billing cycle and the Customer shall make the payment by the due date specified in the bill.
- (f) WTT may suspend or terminate the provision of Service to the Customer and invalidate all Cards issued to the Customer if the Customer or any Registered User is in breach of any of the Conditions and/or the Special Conditions.
