13. IDD007 Calling Card

Effective date: 17/2/97, Revision date: 18/7/98, 16/10/98, 1/1/99, 22/3/99

IDD007 Calling Card enables the Customer to make IDD calls from Hong Kong. Destination and calling rates are as per WTT’s IDD007 service. The following are destinations in addition to those of IDD007 service and their relevant calling rates:

The Home Direct service feature allows Customers to use the IDD007 Calling Card Service to make calls to Hong Kong from the countries below by first dialling the access number specified for a particular country, from a touch-tone telephone. All IDD007 Calling Card Service Customers can automatically use this feature with immediate effect without additional charge. Charges for calls made through the Home Direct service are set out below or otherwise as specified by WTT from time to time. The minimum duration or minimum charge per call is 1 minute.

The following Special Conditions shall apply:

- (a) When WTT accepts an application for IDD007 Calling Card (the “Card”) it will issue a Card, Card or account number and a Personal Identification Number (PIN) to the Customer. The Customer may change the PIN according to the procedure set by WTT. The Customer will be responsible for the security of the Card, account number and PIN. WTT may change any account number or any other

code, number or name allocated by WTT from time to time to the Customer for use in connection with the Card.

- (b) The Card will be valid for use from the validity date until the expiry date notified by WTT to the Customer. The Card and services provided therein are subject to WTT's General Terms and Conditions of Service and the relevant Tariff including these Special Conditions and use of the Card constitutes understanding and acceptance thereof.
- (c) At the request of the Customer, WTT may issue supplementary card to the Customer. The Customer shall be responsible for all charges incurred on the supplementary card. No separate statement will be issued on the supplementary card.
- (d) WTT remains the owner of the Card (including any supplementary card issued) at all times. The Customer shall be responsible for the safe custody of the Card. The Customer must immediately return the Card (including supplementary cards) when WTT requests its return. WTT may demand the return of the Card if any of the services provided through the Card is suspended or terminated.
- (e) The Customer must notify WTT of the loss, theft or misuse of the Card. The Customer will be liable for all charges arising from using the Card until the Customer has notified WTT of the loss, theft or misuse.
- (f) WTT may by notice to the Customer impose a credit limit on the Card. WTT may terminate any or all services provided through the Card if the charges incurred reaches the credit limit set by WTT.
- (g) The Customer will notify WTT of any change of address or any particulars provided to WTT which may affect the provision of services provided through the Card to the Customer.
