**WTT HK LIMITED (“WTT”)**

**S3. International Multi-Protocol Label Switching Virtual Private Network  
 (“Int’l MPLS VPN”)**

Effective date: 24/03/10

This Service is a network-based solution, providing flexible any-to-any connectivity to meet the Customer’s needs. The entire solution operates on a secure and reliable platform with 3 Classes of Service (CoS), namely Premium, Business and Standard to ensure that mission-critical applications enjoy optimal service levels at all times.

This Service covers the sites located both in Hong Kong and overseas with transmission bandwidth from 64k bps to 10M bps, or even higher bandwidth.

Monthly Rental Charges include the charges for local port and tail circuit in the respective region and are indicative only; final costs will be confirmed after the actual site survey.

The following Special Conditions shall apply in respect of the Service:

1. Definition of Terms

"Customer Site" means the Customer's premise(s) in Hong Kong connected to WTT Termination Point by a Local Leased Line.

"Far End Customer Site" in relation to an Int'l MPLS VPN means the Customer's premise(s) located outside Hong Kong where the corresponding Far End Port for the Service terminates.

"Far End Port" means the corresponding international dedicated transmission facility between the Service interface and the Far End Customer Site approved by WTT.

"Far End Operator" means the telecommunications service operator that provides the corresponding Far End Port for the Service.

"Local Leased Line" means the local leased transmission facility between the Customer Site and WTT's Termination Point.

"Local Operator" means any person authorised under the Telecommunication Ordinance to provide Local Leased Lines.

"WTT Termination Point" means the premises designated by WTT as the termination point for the Service.
2. Provisioning
  - 2.1 Int'l MPLS VPN service will only be supplied to the Customer subject to actual service availability, as confirmed by WTT at the time of ordering.

- 2.2 Local Leased Lines service necessary to support the Int'l MPLS VPN service may not be available to all proposed Customer Site, and Far End Half Ports may not be available to all proposed Far End Customer Site.
  - 2.3 The Int'l MPLS VPN Commencement Date is subject to the availability of the Local Leased Line and the Far End Port. WTT will decide and notify the Customer of the Commencement Date.
  - 2.4 WTT will have no liability for any losses that may be suffered by any person as a result of failing to meet a proposed Int'l MPLS VPN Commencement Date.
  - 2.5 The quality of transmission using the Int'l MPLS VPN will depend on the quality of the Far End Port and the Local Leased Line.
  - 2.6 The Customer must provide to WTT and the Far End Operator information and assistance required for implementing and commissioning the Int'l MPLS VPN.
  - 2.7 The Customer must ensure that WTT and the Far End Operator have access to the Customer Site and Far End Customer Site respectively at reasonable hours on giving reasonable notice for the purposes of provisioning of the Int'l MPLS VPN.
  - 2.8 The Customer understands that additional terms and conditions may apply in relation to specific network platforms.
3. Minimum Subscription Period
    - 3.1 The Minimum Subscription Period in relation to each Int'l MPLS VPN is 1 year from the relevant Int'l MPLS VPN Commencement Date unless otherwise agreed.
    - 3.2 If the Customer terminates the Int'l MPLS VPN service prior to the expiration of the Minimum Subscription Period, the Customer must pay an early termination charge based on the monthly rental multiplied by the remainder of the Minimum Subscription Period on demand.
4. Use of Int'l MPLS VPN
    - 4.1 The Customer:
      - (a) must not directly or indirectly connect the Int'l MPLS VPN or the Local Leased Line or any other service or equipment connected to the Int'l MPLS VPN or Local Leased Line to any public switched telephone network ("PSTN") in Hong Kong, or allow third persons to pass communications directly or indirectly between the PSTN and the Int'l MPLS VPN in Hong Kong, whether as a single transaction or separate transactions including on a store and forward basis; and
      - (b) must not directly or indirectly allow the Int'l MPLS VPN to be used by or shared with any third party
