Any MNO, who directly or indirectly passes the type of calls referred to above to WTT Network, shall be deemed to have accepted the above Tariff.

PMRS/PCS operators shall pay the following applicable charges to WTT for use of WTT's mobile number portability Database Interrogation Service for checking whether a PMRS/PCS subscriber number is ported or not:

(c)	Calls originated from any PMRS/PCS network which uses the database interrogation service provided by WTT	2.53 cents per database interrogation

- 1. "PMRS" refers to Public Mobile Radiotelephone Services. "PCS" refers to Personal Communications Services.
- 2. Requests for Database Per Subscriber Set-up Service will be processed in accordance with the Code of Practice Related to the Implementation of Mobile Number Portability and other subsidiary standards documents such as HKTA 2103, HKTA 2104 and MNP Document 3 issued by OFTA.
- 3. Charges will be charged for all processed requests for the service.
- 4. Charges will be charged for all call attempts utilising the service.
- "ETS" refers to External Telecommunications Services.
- Charges provided do not include other charges such as any applicable line charges, local access charges, international call charges, Universal Service Contribution or other charges as indicated.
