<u>Description</u>	<u>Charge (HK\$)</u>
(1) Administration Charge for invoices rendered to customers for payment of less than HK\$50.00	\$6.00 per invoice
(2) Administration Charge for generating and/or processing the first two monthly call or traffic records per each customer account (notes 1 and 2)	\$22,000.00
(3) Administration Charge for generating and/or processing each additional monthly call or traffic record per each customer account subsequent to item (2) above (note 1)	\$6,500.00
(4) Administration Charge for change of Customer’s information or details, such as Business Registration number; registered company name; registered address; postal address; billing address; contact person’s name and title; telephone number; fax number; mobile number; e-mail address	HK\$600 per change

Notes:

1. Call or traffic record with period shorter than one month will be treated as one month. No prorate adjustment will be made.
2. The minimum charge for item (2) is \$22,000.00, irrespective of whether the period upon which the monthly call or traffic record(s) generated and/or processed is equal to or less than two months.
