Services-based Operators ("SBO") directly connected to WTT's Network shall pay the following applicable LAC to WTT for use of WTT's Network for delivery of ETS calls:

Type of calls		Charges ^(note 3) (HK\$ per occupancy minute ^(note 4))
1.	Incoming ETS calls directly terminated on WTT's Network	20 cents
2.	Incoming ETS calls that transit WTT's Network for termination on another Fixed Network ^(note 1)	3 cents plus charges levied by third party
3.	Incoming ETS calls that transit WTT's Network for termination on a Mobile Network ^(note 2)	3 cents plus charges levied by third party
4.	Outgoing ETS calls originated from a WTT customer line	20 cents
5.	Outgoing ETS calls originated from another Fixed Network that transit WTT's Network	3 cents plus charges levied by third party
6.	Outgoing ETS calls originated from a Mobile Network that transit WTT's Network	3 cents plus charges levied by third party

Fixed Network and Mobile Network operators shall pay the following LAC charges to WTT as applicable for ETS calls that terminate on, or originate from, WTT's Network:

Type of Calls	Charges ^(note 3) (HK\$ per occupancy minute ^(note 4))
7. Incoming ETS calls terminated on WTT's Network	18 cents
8. Outgoing ETS calls originated from WTT's Network	18 cents

Notes:

- Fixed Network refers to a network operated by a holder of Unified Carrier Licence (with authorization to provide fixed service) / Fixed Carrier Licence / Fixed Carrier (Restricted) Licence / Fixed Telecommunications Network Services Licence.
- Mobile Network refers to a network operated by a holder of Mobile Carrier Licence / Mobile Carrier (Restricted) Licence / Unified Carrier Licence (with authorization to provide mobile service). For clarity, it includes the Mobile Virtual Networks of SBO (Class 3 - mobile virtual networks service).
- 3. Charges exclude any applicable line charges or any international call charges or any Universal Service Contribution charges or other charges as indicated.
- Occupancy minute refers to the time measured over the interconnection line or circuit between the seizure of a circuit and the release of the circuit.
