

**UNIFIED CARRIER LICENCE  
TELECOMMUNICATIONS ORDINANCE (Chapter 106)**

**WTT HK Limited (“WTT”)**

**W5. bArchive**

Effective date: 04/05/11

bArchive is an archiving solution for mails sent in or out through bMail IMAP/ POP3 and SMTP upon subscription of service. It allows the Customer to access archived information stored in their account(s) with an Internet browser when they are connected online.
